Upon roll call vote of the original motion to approve Ordinance O-08-6-104 - Ordinance of the Commission of Knox County, Tennessee, repealing Ordinance O-08-4-101 and amending Article IX, Section 9.05 of the Knox County Charter to modify the appointment and process of the Charter Review Committee and to establish the deadline for submission of a Charter Amendment to the County Election Commission in accordance with State Law (Ordinance O-08-4-101, May 27, 2008 and Knox County Charter as adopted November 8, 1988, as amended through Referendum of August 6, 2004 on second reading with the following amendment: the Charter Review Committee will give a report to the Knox County Commission once it is completed; the Knox County Commission will be afforded the opportunity to give recommendations and if there are any concerns about any illegality, the Knox County Commission can recommend that the report go back to the Charter Review Committee for further work, but, the Knox County Commission is not to change the intent or spirit of the work product; and the Ordinance should be approved on first reading and not second reading, Commissioners Campen, Ivan Harmon, Davis, Daniels, Rountree, Lambert, Smith, Moore, Ballard, Wright, DeFreese and Pinkston voted aye. Commissioners McKenzie, Strickland, Norman, Hammond, Craig Leuthold and Briggs voted no. Commissioner Mark Harmon was absent from the meeting. The motion failed 12-6-0-1.

Commissioner Moore moved to approve Ordinance O-08-6-104 - Ordinance of the Commission of Knox County, Tennessee, repealing Ordinance O-08-4-101 and amending Article IX, Section 9.05 of the Knox County Charter to modify the appointment and process of the Charter Review Committee and to establish the deadline for submission of a Charter Amendment to the County Election Commission in accordance with State Law (Ordinance O-08-4-101, May 27, 2008 and Knox County Charter as adopted November 8, 1988, as amended through Referendum of August 6, 2004 on second reading. Commissioner Pinkston seconded the motion and upon roll call vote Commissioners Ivan Harmon, Davis, Daniels,

Lambert, Moore, DeFreese and Pinkston voted aye. Commissioners McKenzie, Strickland, Campen, Norman, Hammond, Craig Leuthold, Briggs, Rountree, Smith, Ballard and Wright voted no. Commissioner Mark Harmon was absent from the meeting. The motion failed 7-11-0-1.

IN RE: AMENDMENTS TO THE AGENDA – (CONTINUED):

At this time, there was discussion regarding the requirement to have two (2) public hearings prior to the following Ordinance being approved on second reading: Ordinance O-08-7-102 – Ordinance of the Commission of Knox County, Tennessee, amending Article II, Section 2.02 and Article III, Section 3.03 of the Knox County Charter to establish a two (2) term limit on all members appointed to boards, commissions and authorities (Knox County Charter as adopted November 8, 1988, and amended).

Commissioner Strickland indicated he would schedule two (2) public hearings at a later date and post the information on the website.
