Consideration of a Resolution of the Commission of Knox County, Tennessee appointing \_\_\_\_\_ to serve the unexpired term of Knox County Law Director through August 31, 2012 was before the Board of Commissioners.

Upon roll call vote for nominations for Knox County Law Director Commissioner Strickland nominated Mr. George Underwood, Commissioner Broyles nominated Mr. Joe Jarret, Commissioner Norman passed, Commissioner Ivan Harmon passed, Commissioner Saunders passed, Commissioner Shouse passed, Commissioner Hammond passed, Commissioner Leuthold passed, Commissioner Briggs passed, Commissioner Anders passed, Commissioner Lambert passed, Commissioner Smith nominated Mr. David Buuck, Commissioner Carringer passed, Commissioner Armstrong passed, Commissioner Wright passed, Commissioner Brown passed and Commissioner Pinkston passed. Commissioners Mark Harmon and McKenzie were absent from the meeting.

Mr. George Underwood, Mr. Joe Jarret and Mr. David Buuck were the nominees for Knox County Law Director.

Upon roll call vote for Knox County Law Director Commissioner Strickland voted for Mr. George Underwood, Commissioners Broyles, Norman, Ivan Harmon, Saunders, Shouse, Hammond, Leuthold, Briggs, Anders, Lambert, Smith, Carringer, Armstrong, Wright, Brown and Pinkston voted for Mr. Joe Jarret.
