Knox County ADA Transition Plan Adopted August 2019

Knox County Accomplishments of 2020

1. The citizen's disability advisory group, DAGWould?, met in-person in January and February before transitioning to electronic meetings in June, September and November.
2. The county and city ADA Coordinators held four ADA training sessions for a total of 135 county employees in January.
3. Community Television (CTV) began closed captioning of county meetings at the end of January.
4. County Commission approved a design contract in January with Barge Design Solutions to redesign the Peters Road/Ebenezer Road sidewalks to meet ADA requirements for \$250,000. Design is underway. The project includes 7.34 miles of sidewalks, 87 driveways, 20 unsignalized intersections and 6 signalized intersections that will be upgraded.
5. County Commission approved a design contract in January with SL King & Associates to redesign the Cedar Bluff Road sidewalks to meet ADA requirements for \$67,000. Design is nearly complete. The project includes 1.45 miles of sidewalks, 31 driveways and 25 unsignalized intersections. Please note that the signalized intersections will be upgraded in 2021 as part of the ATMS Phase I project.
6. The fiscal year budget for 2021 has a line item of \$1,200,000 for ADA capital projects. The budget was approved in June 2020.
7. A separate line item in the FY2021 budget includes \$11,585 for reconstructing the ramp at the Corryton Branch Library as the design has been completed.
8. DAGWould? members participated in the survey for the Human Services Transportation Plan and at their September meeting were presented the draft plan by TPO staff.
9. An RFQ was issued in October for bringing Carter Park into compliance with ADA. Responses were due in November and the "Intent to Award" letter is to be sent the week of December 7, 2020.
10. Automatic doors were contracted in November through PBA to be installed at the Karns Senior Center for \$4955. Even though not an ADA requirement, the doors have been requested by the seniors who use the facility as they have mobility needs. Once the automatic doors are installed, barriers 2 and 6, regarding the threshold and door stop, will be eliminated.

Barriers Removed in 2020

Per the Self-Evaluation conducted as part of the development of the Transition Plan, the following facilities were evaluated:

- 142 buildings and 44.8 miles of associated sidewalk, unsignalized intersections and driveways;
- 47 parks and 15.1 miles of associated sidewalk, unsignalized intersections, and driveways;
- 7 greenways and 9.1 miles of associated sidewalk, unsignalized intersections and driveways;
- 82 signalized intersections; and
- 140.1 miles of public rights-of-way sidewalk and all unsignalized intersections and driveways along the sidewalk corridors.

Each of the following departments were asked to provide information about the barriers that were removed in 2020. A total of 91 barriers were removed with up to 21 others partially removed.

Engineering and Public Works has three areas of compliance for the public right-of-way: sidewalks, signalized intersections and unsignalized intersections. Between 12 and 21 sidewalk locations were repaired as part of maintenance work, but the department did not specify if the barriers were only partially removed or completely removed. The address provided was matched to the corridor in the plan. Question marks next to the barrier number in the spreadsheet indicate the inability to confirm the exact location of the barrier. Please see the attached spreadsheet for the locations and the barriers that were at least partially removed.

Library Facilities had 18 buildings reviewed. This year simple maintenance items were done at 14 libraries that removed 77 barriers. See the attached spreadsheet for each of the numbered barriers at each location that was removed.

Parks and Recreation is responsible for both parks and greenways. The department reported no work has been done in 2020 to remove barriers.

PBA Managed/Other Facilities had 20 facilities reviewed. A total of 13 barriers were removed from the following eight (8) facilities.

- Dante Clinic removed barrier #4 as the signage was relocated to the latch side of the door.
- Fairview Technology Center removed barrier #3 by removing the bollard from the access aisle.
- Family Investment Center removed barrier #3 when the van accessible sign was installed.
- Family Justice Center removed barrier #13 when the paper towel dispenser was relocated out of the circulation path.
- Juvenile Justice Center removed two (2) barriers. Removing the door stop eliminated barrier #6 and barrier #39 was removed when drain pipes and water lines were insulated.
- Knox Central Building had four (4) barriers removed. The door closure has been adjusted to eliminate barrier #13. The paper towel dispenser was lowered to remove barrier #17. The vending machine, barrier #26, was replaced by Procurement and directional signage to the elevators to get to Records Management (barrier #50) was installed by PBA.
- Main Health Department had two (2) barriers removed. Drain pipes and water lines were insulated removing barrier #55 and the soap dispenser was moved (barrier #78) to the correct height.
- Old Court House has removed the existing signage (barrier #15) which lacked contrast with the background and has ordered new signage.

Schools had 89 facilities reviewed. No work has been reported on barrier removal.

Senior Centers had 6 facilities reviewed. At the Karns Senior Center the vending machine was replaced (barrier #4).

Waste Centers had 7 facilities reviewed. No work has been reported on barrier removal.

Other Programs/Department Facilities had 2 facilities reviewed. No work has been reported on barrier removal.
