Registered owner/owners who is 65 years old or older **AND** has a combined annual income equal to or less than 14,100.00 per year. **\$30.00 EXEMPTION**

Documentation required: Driver's License or birth certificate, **AND** one (1) of the following for which you qualify:

Income Tax Return – (1040A form)

OR Current Year Social Security Statement (if 1040A income tax form was *not* filed)

Registered owner who has been certified as totally disabled by the Social Security Administration or the U.S. Dept. of Veteran's Affairs **AND** has a combined annual income equal to or less than \$14,100.00 per year. **\$30.00 EXEMPTION**

Documentation required: Driver's License or birth certificate **AND** one (1) of the following for which you qualify:

- Award of SSI (supplemental security income)
- Award of SSD (social security disability)
- Award of Welfare
- Award of Worker's Compensation, permanent, 100%
- Award of Unemployment Compensation
- Award of Disabled VA or is a former Prisoner of War

Registered owner/owners of the vehicle who are active duty members of the United States Army, Navy, Marine Corps, Air Force, and Coast Guard **OR** members of the Army Reserve, Naval Reserve, Marine Corps Reserve, Air Force Reserve, Coast Guard Reserve, Army National Guard and Air National Guard who are called to full-time active duty service. **\$36.00 EXEMPTION**

Documentation required: Copy of Leave and Earnings Statement (LES)

Registered owner is a veteran who has a 100% permanent total disability from a service-connected cause **OR** is a former prisoner of war, as determined by the U.S. Dept. of Veterans Affairs. **\$36.00 EXEMPTION**

Documentation required: DD214 Certificate or other appropriate VA related forms

Registered owner **OR** the dependent of the registered owner who has been certified by a physician to be permanently and totally confined to a wheelchair. **\$36.00 EXEMPTION**

Documentation required: Certification by physician.

School bus under contract with Knox County Board of Education. **\$36.00 EXEMPTION**

Documentation required: Certification from Knox County Schools
