Category Two Cases - \$259.50

Appeals to the circuit court, writs of certiorari, transfers from foreign counties, worker's comp, and condemnations.

*Third Party Complaint - \$152.00

Category Three Cases - \$209.50

Restoration of citizenship, name changes, minor settlements, foreign judgments and all other court approved settlements.
