**IN RE: DISCUSSION OF ORDINANCE O-22-12-101 - ORDINANCE OF THE COMMISSION OF KNOX COUNTY, TENNESSEE, AMENDING THE KNOX COUNTY CODE, APPENDIX A – ZONING, ARTICLE 3, BY ADDING SECTION 3.100, TEMPORARY USES, WHICH INCLUDES USE STANDARDS FOR TEMPORARY OCCUPATIONS OF A RECREATIONAL VEHICLE, CAMPER OR OTHER NON-PERMANENT HABITATION, AND ARTICLE, BY ADDING SECTION 6.12, PERTAINING TO TEMPORARY USE PERMIT (AMENDS ORDINANCE O-90-9-130, ADOPTED SEPTEMBER 10, 1990, AS AMENDED - (SECOND READING):**
