AP-05 EXECUTIVE SUMMARY - 24 CFR 91.200(C), 91.220(B)

Introduction

Situated in the heart of East Tennessee, Knox County has experienced consistent population growth over the past four decades. In 1980, the population stood at 320,000; and by 2022, the county experienced a 55 percent increase, reaching 500,000 residents. As the population continues to grow so does the need for an increased stock of affordable housing and public services.

Knox County Grants and Community Development (KCGCD) serves as the lead agency for the County's U.S. Department of Housing and Urban Development (HUD) funding allocations. Every five years, KCGCD submits a Consolidated Plan (Con Plan) to HUD. The Con Plan establishes a unified, coordinated vision for community development actions for the upcoming five years using Community Development Block Grant (CDBG), HOME Investment Partnerships (HOME), as well as CARES Act (CDBG-CV) funding. The community development and housing needs of the County are determined through citizen input and community partner collaboration.

The 2020 – 2024 Con Plan priority needs include:

1. Increase Affordable Rental Housing Opportunities
2. Increase Affordable Homeownership Opportunities
3. Provide a Wide Variety of Public Services
4. Provide Homeless Housing and Services
5. Improve the Quality of Existing Housing Stock
6. Economic Development
7. Provide facilities and services in support of the pandemic response and recovery efforts

To address these priority needs, the County partners with the Continuum of Care (CoC), nonprofit and for-profit organizations, community groups, and other County departments.

This 2024 Annual Action Plan (AAP) represents the final year of the County's current five-year Con Plan. The AAP identifies the County's priorities for housing, community development, and public service needs for low-to-moderate-income residents and outlines the strategies, resources, and networks that will be implemented to address these needs during Program Year 2024. Program Year (PY) 2024 runs from July 1, 2024, through June 30, 2025.

Summarize the objectives and outcomes identified in the Plan

The purpose of the programs is to provide decent housing, a suitable living environment, and economic opportunities for low-moderate income residents. The County strives to accomplish these goals by maximizing and effectively utilizing all

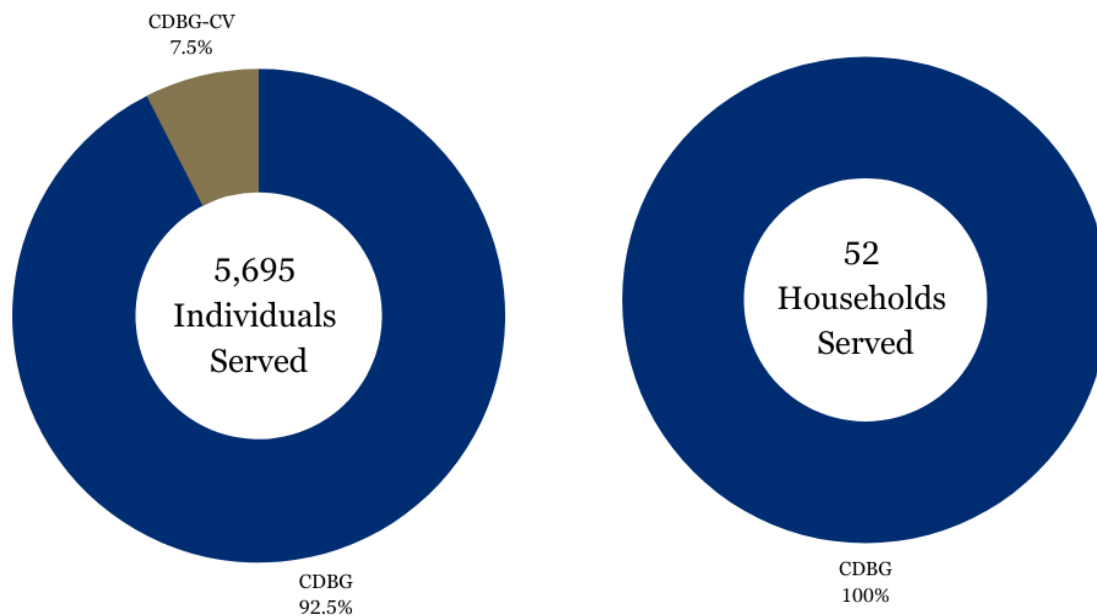
available funding resources to conduct housing and community development activities. With the resources made available to the County in PY 2024, the following goals have been identified and will be addressed:

- Increase Affordable Homeownership Opportunities
- Improve the Quality of Existing Housing Stock
- Provide Infrastructure to Create Affordable Housing
- Provide a Wide Variety of Public Services
- Provide Homeless Housing and Services
- Provide facilities and services in support of the pandemic response and recovery efforts

Evaluation of past performance

Knox County's evaluation of its past performance is completed in a thorough Consolidated Annual Performance and Evaluation Report (CAPER). The CAPER details the performance of the outcomes and objectives identified in its associated AAP. The charts below represent the residents served through home rehabilitation assistance, homeless housing services, and public service needs in PY 2022.



Despite challenges with the increase in housing construction costs and demand for skilled laborers, Knox County subrecipients were successful in meeting and, in some cases, exceeding project performance goals and objectives.

Currently Knox County is implementing the PY 2023 Annual Action Plan, the fourth year of the 2020 – 2024 Con Plan.

Summary of Citizen Participation Process and Consultation Process

The County values public involvement in defining and understanding community needs, including community development, economic development, and fair housing needs. The draft 2024 Annual Action Plan was made available on the KCGCD website on March 18, 2024, and paper copies were made available at the KCGCD office and two community locations. Notice of the comment period, the hybrid Public Hearing, and the Knox County Commission Hearing date were published in the Knoxville Focus and distributed via email to all agencies engaged in the consultation process.

Summary of public comments

Knox County Grants & Community Development received several comments and questions during the application period and no comments were received at the Action Plan public hearing. In summary, most questions were in relation to the types of services that could be offered using CDBG funding if awarded, how the application and subrecipient selection process works, and the timeline for subrecipient notification of award and HUD approval of the annual action plan. AP-10 CONSULTATION – 91.100, 91.200(B), 91.215(L)

Introduction

Knox County continuously fosters transparent and meaningful community involvement in the allocation and utilization of local, state, and federal funding programs within Knox County. By actively engaging residents, local organizations, and stakeholders in action planning, it ensures that federal funds are directed toward projects and initiatives that align with community needs and aspirations. Stakeholders include affordable/accessible housing providers, social and health services agencies, and entities serving children, youth, and the elderly. The County sent emails to agencies, advising them of the Action Planning process, public hearing dates, and other opportunities to comment, and requesting comment regarding the process.

Provide a concise summary of the jurisdiction’s activities to enhance coordination between public and assisted housing providers and private and governmental health, mental health, and service agencies (91.215(l))

Throughout the PY 2024 AAP process, KCGCD consulted with non-profit organizations, government agencies, and social service providers that focus on affordable/accessible housing, homeless services, mental and physical health, and youth development. The process began with the opening of applications for CDBG funding for Construction & Infrastructure, Housing Stability, and Public Services. Two application workshops were held in a hybrid format to allow for in-person and virtual participation in January 2024. The draft of the AAP was open for public comment for 30 days, with a public hearing held by KCGCD on April 4, 2024. Agencies and citizens were encouraged to provide input at the monthly Knox County Commission work session in April as an additional public hearing opportunity before the County Commission voted on the AAP. All public hearings and the public comment period were properly public noticed in the Knoxville Focus and KCGCD’s website. Full details on the citizen participation and consultation process can be found in Appendix A of this document.

Describe coordination with the Continuum of Care and efforts to address the needs of homeless persons (particularly chronically homeless individuals and families, families with children, veterans, and unaccompanied youth) and persons at risk of homelessness.

Knox County is committed to mitigating homelessness among its residents and engages in active collaboration with the Continuum of Care (CoC). The Knoxville-Knox County Homeless Coalition functions as the CoC for the community. In partnership, Knoxville, Knox County and the CoC offer a variety of housing solutions, including emergency shelters, transitional housing, and permanent supportive housing, with a specific focus on households facing housing instability or chronic homelessness.

In conjunction with the City of Knoxville, Knox County has established the joint Knoxville-Knox County Office of Housing Stability. This collaborative effort involves close coordination with the CoC, Knoxville-Knox County Homeless Coalition, housing agencies, homeless service providers, and individuals with lived experience of

homelessness. Their collective focus is to shape a unified vision with shared objectives, guided by a comprehensive, data-driven, evidence-based approach at the systemic level. The primary goal is to proactively prevent homelessness, sustain family residences, and streamline access to housing options and essential services for individuals and families.

In recognition of the increasing population of individuals without stable housing, the County has placed a strong emphasis on allocating resources to evaluate and cater to the needs of homeless individuals. The County has directed CDBG and CDBG-CV funds, as well as local funds, U.S. Department of Treasury Emergency Rental Assistance (ERA), and Coronavirus State and Local Fiscal Recovery Funds (SLFRF) to address this issue. Funds are dedicated to services that connect persons experiencing homelessness to housing; preserving existing housing stock through its owner-occupied home rehabilitation program; and rent, mortgage, and utility assistance for individuals at risk of becoming homeless. The County will utilize its allocation from the HOME Investment Partnerships American Rescue Plan Program (HOME-ARP) to effectively respond to the needs of families and individuals experiencing homelessness or facing a risk of homelessness in the coming years.

Describe consultation with the Continuum(s) of Care that serves the jurisdiction's area in determining how to allocate ESG funds, develop performance standards for and evaluate outcomes of projects and activities assisted by ESG funds, and develop funding, policies and procedures for the operation and administration of HMIS

The Knoxville/Knox County CoC utilizes a Homeless Management Information System (HMIS) through the University of Tennessee, Knoxville Social Work Office of Research and Public Services. KnoxHMIS is integral in the community's coordinated entry system, Coordinated Housing Assessment and Match Plan (CHAMP). CHAMP is a comprehensive intake and assessment procedure involving multiple agencies, aiming to link individuals and families experiencing homelessness with the most suitable resources and housing options within the community.

While the County does not currently receive Emergency Solutions Grant (ESG) funds, the publicly disseminated data collected through KnoxHMIS informs the CoC and the County's priorities and strategies for addressing the needs of those experiencing homelessness.



Knoxville/Knox County Continuum of Care's Coordinated Housing Assessment and Match Plan

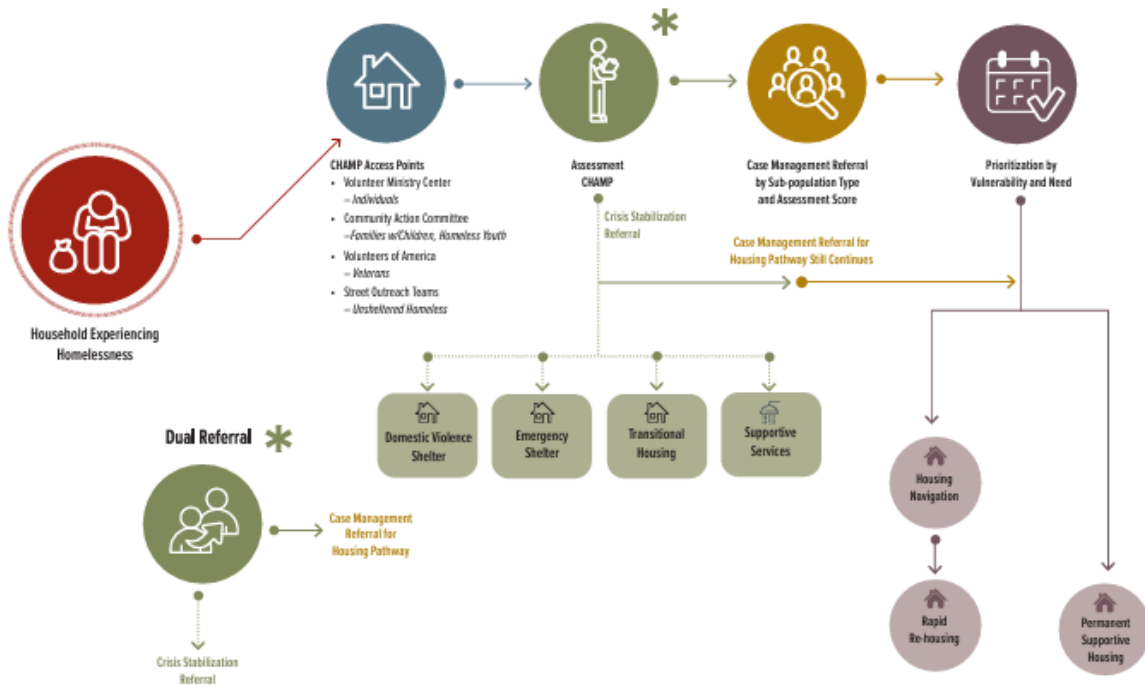


Figure 1 – Knoxville/Knox County CoC CHAMP¹

KCGCD made every effort to be inclusive in its consultation. We plan to consult both broadband internet service providers and agencies tasked with hazard mitigation during our upcoming consolidated planning process (we added this step during the development of the County's 2020-2024 ConPlan). We used CPD-20-04 as our guide on incorporating the new broadband and natural hazards requirements and did not realize that additional consultation was required for the annual action plan.

While we did not have a formal consultation with these agencies while preparing our AAP, we work closely with our local emergency management agency, engineering and public works department, and utility providers. We frequently seek their advice and feedback on potential projects and are currently partnering on several initiatives focused on increasing broadband access, increasing community resilience, mitigating natural hazards, and improving water quality within the County. In the future, we will include a formal consultation with these stakeholders as part of our annual action planning process.

The County continues collaborations with local agencies and non-profit organizations to optimize resources and enhance results in housing and community development initiatives. Leveraged resources encompass, among others, Continuum of Care dollars, Housing Authority resources, mental health, drug and alcohol services, and LIHTC. As a HOME Participating Jurisdiction (PJ), the County must contribute or match its annual HOME allocation with no less than 25 cents for each dollar of HOME funds spent on affordable housing. This match may involve:

- Cash
- Donated construction materials or volunteer labor
- Value of donated land or real property
- Value of foregone interest, taxes, fees, or charges levied by public or private entities.
- Investments in on-or offsite improvements
- Proceeds from bond financing.
- The cost of supportive services provided to families living in HOME units.
- The cost of homebuyer counseling to families purchasing HOME-assisted units

If appropriate, describe publicly owned land or property located within the jurisdiction that may be used to address the needs identified in the plan

Although Knox County typically does not acquire property, ownership of single-family housing may be obtained through non-payment of property taxes. These properties are auctioned biannually through a Tax Sale, enabling developers or individuals to acquire housing for potential use in accommodating LMI individuals. While specific sites are not currently designated, there could be future situations where the County retains ownership and leases the property to a housing developer to establish affordable housing.

Discussion

Knox County's targeted allocation of HUD funds underscores a multifaceted approach to community development. By prioritizing public services, public facilities, street improvements, and affordable housing, the county aims to enhance residents' quality of life. This strategy encompasses supporting essential services, creating vibrant communal spaces, improving infrastructure, and addressing the critical need for affordable housing. In doing so, Knox County seeks to foster a resilient, accessible, and thriving community for its residents.

However, the supply of available housing has struggled to keep pace and home builders have faced ongoing challenges from labor shortages and escalating material costs. First-time homebuyers, aging individuals, and disadvantaged groups have experienced the largest shortage of options.

The current housing landscape in Knox County underscores the importance of prioritizing initiatives that uphold the preservation of naturally occurring affordable housing options and the expansion of affordability within the community. The County is dedicated to consistently monitoring housing market dynamics and adapting project strategies in response to changing circumstances.

Discussion

The distribution of HUD funds will play a crucial role in steering projects focused on improving access to high-quality affordable rental housing, strengthening essential infrastructure to support the expansion of affordable housing stock, executing efforts to restore affordable single-family homes, and actively promoting the overarching objective of elevating homeownership rates throughout the community.

AP-60 PUBLIC HOUSING – 91.220(H)

Introduction

Knoxville's Community Development Corporation (KCDC) serves the needs of all the public housing residents within the City of Knoxville and Knox County. KCDC owns, manages, and maintains nearly 4,000 low-income rental units across the community. Additionally, KCDC administers a program that allows over 4,000 families to secure affordable housing in the private market.

Actions planned during the next year to address the needs to public housing

KCDC has transformed public housing in both the City and County using the HUD Rental Assistance Demonstration (RAD) program. All properties in the KCDC portfolio have undergone conversion, with the exception of Western Heights Addition (3-4), which is currently in the process of conversion. Additionally, KCDC's newest development, Liberty Place, will provide 32 units of HUD-Veterans Affairs Supportive Housing (VASH) Project Based Vouchers (PBV) housing for homeless or at-risk-of-homelessness vets. This development is expected to open in late 2024. The resources provided through the RAD program have enabled KCDC to consistently pursue its mission. Converting units to rental-based housing grants has allowed KCDC access to the same financing options as the private sector, enabling them to leverage private capital markets for capital improvements in the public housing stock.

Modernization and rehab have been ongoing for all four KCDC high-rise properties for elderly and disabled adults. KCDC is near completion on Phase 2 of First Creek of Austin, which will add 180 units of affordable housing. Phase 3 is expected to add 161 more units in 2025. KCDC opened the first 105 mixed-income units from Phase 1 in 2022. Through a HUD Choice Neighborhoods grant, KCDC will open the first phase of mixed income housing at Western Heights in 2025 to include 76 units.

Actions to encourage public housing residents to become more involved in management and participate in homeownership

Management actively fosters connections with their sites through community-centered activities, including recognizing graduates at their properties, hosting resource "fairs," and organizing other neighborhood-building events.

Residents actively engaged in the planning of the two latest neighborhood redevelopment initiatives, First Creek at Austin and Western Heights, through regular community meetings. The HUD Choice Neighborhood grant was awarded to KCDC for the comprehensive transformation of the Western Heights community and its surrounding neighborhood. Collaborating with community agencies is a key strategy for KCDC to enhance resident involvement.

If the PHA is designated as troubled, describe the manner in which financial assistance will be provided or other assistance

KCDC is not "troubled" under 24 CFR Part 902.

Discussion

While Knox County does not own or operate a public housing authority, Knox County actively partners with KCDC to meet the needs of Knox County residents. Through the Tennessee Housing Development Agency (THDA) Eviction Prevention program, KCGCD has worked with KCDC to keep families housed. Since November 2023, the Knox County Eviction Prevention Program has expended over \$9,734,931.28 in funds to serve 2,129 households. The Knox County Eviction Prevention Program prevents evictions by strengthening housing stability with financial assistance, legal representation, case management, counseling, and access to coordinated funding.

AP-65 HOMELESS AND OTHER SPECIAL NEEDS ACTIVITIES – 91.220(I)

Introduction

KCGCD produced the report *Homelessness in Knox County*² in collaboration with local nonprofit agencies, faith-based organizations, the City of Knoxville, and various county departments. The document was created to deepen our understanding of homelessness and help guide allocations of funding. It considers the unique impacts and available resources in Knox County to identify effective solutions for our community. While homelessness manifests uniquely for each individual or family, "significant contributors" have been identified and narrowed down to housing, mental health, substance misuse, and the need for additional support networks. With lack of accessible and affordable housing being the top response.

Describe the jurisdictions one-year goals and actions for reducing and ending homelessness including:

Reaching out to homeless persons (especially unsheltered persons) and assessing their individual needs

In response to the increasing population of individuals without stable housing, the County has emphasized allocating resources to evaluate and cater to the needs of homeless individuals. CDBG and CDBG-CV funds will be utilized to support social service agencies and outreach programs that provide and assist with housing, as well as identifying additional wrap-around service needs, such as healthcare and employment. The Knoxville-Knox County Office of Housing Stability will serve as the liaison for local government, private and public sectors, and social services agencies. Active coordination across all sectors will create resilience in efforts to prevent and respond to housing instability and homelessness.

Addressing the emergency shelter and transitional housing needs of homeless persons

Like many communities, the demand for emergency shelters and transitional housing has surged due to an increase in homelessness and a shortage of affordable housing. Emergency shelters are typically at full capacity, with extended lengths of stay. Since 2021, the median shelter stay has increased by 21%, with it being 49 days at the end of 2023.³ Presently, Knox County has a capacity of 464 beds in emergency shelters and 196 beds in transitional housing.

While Knox County does not currently receive Emergency Solutions Grant funds, it continues to use the data collected by KnoxHMIS to inform planning processes and prioritization of not only HUD funding but also State and Local Fiscal Recovery Funding.

Helping homeless persons (especially chronically homeless individuals and families, families with children, veterans and their families, and unaccompanied youth) make the transition to permanent housing and independent living, including shortening the period of time that individuals and families experience homelessness, facilitating access for homeless individuals and families to affordable housing units, and preventing individuals and families who were recently homeless from becoming homeless again

The community-wide approach to addressing homelessness, the *2014 Knoxville-Knox County Continuum of Care Plan*, emphasizes the creation of new housing and increasing economic opportunity. While the support for the Housing First and Rapid Rehousing Models is at the forefront of planning, Knox County recognizes the shortage of unoccupied units. To supplement these models, the County supports the development of transitional housing and emergency shelters to increase the options for support services for those experiencing a wide range of needs associated with unstable housing.

Per KnoxHMIS data, Knox County has seen an increase in family and youth homelessness reported in rural areas of Knox County. The County will continue to support efforts focusing on street outreach to the unsheltered homeless, especially unsheltered youth and unsheltered chronically homeless through CDBG funding.

Knox County will continue to invest in the prevention of homelessness and provide the necessary resources to maintain housing stability.

Helping low-income individuals and families avoid becoming homeless, especially extremely low-income individuals and families and those who are: being discharged from publicly funded institutions and systems of care (such as health care facilities, mental health facilities, foster care and other youth facilities, and corrections programs and institutions); or, receiving assistance from public or private agencies that address housing, health, social services, employment, education, or youth needs.

Factors including increased home prices, limited housing supply, growth in population, and rental pricing increases have resulted in housing hardships for homeless and low-to-moderate-income individuals and families. Knox County will utilize CDBG and CDBG-CV funds to invest in the prevention of homelessness and provide the necessary resources to maintain housing stability. The County plans to fully utilize its allocation from the HOME Investment Partnerships American Rescue Plan Program (HOME-ARP) to effectively respond to the needs of families and individuals experiencing homelessness or facing a risk of homelessness in the upcoming year.

The Knoxville-Knox County Office of Housing Stability's primary focus is to expand and manage partnerships, align, and leverage resources, and encourage evidence-based initiatives that keep families in their homes, connect people to housing opportunities and services, and make experiences of homelessness rare, brief, and non-recurring. The office will collaborate with the local housing agencies, homelessness service providers, and residents to set a common vision with shared goals informed by a systems-level,

evidence-based approach focused on keeping families in their homes and connecting people to housing opportunities and services.

Discussion

The County remains committed to its collaborative efforts, building partnerships with the CoC, non-profit entities, and faith-based organizations. This collective engagement is driven by a shared commitment to addressing the needs of residents without stable housing and offering vital support to individuals and families undergoing housing hardships. Through these alliances, the County endeavors to implement comprehensive strategies aimed at not only providing immediate assistance but also working toward the stabilization of vulnerable populations within the community. By leveraging the diverse strengths and resources of these collaborative partners, the County aims to create a more resilient and supportive environment for those facing housing challenges.

AP-75 BARRIERS TO AFFORDABLE HOUSING – 91.220(J)

Introduction:

According to the East Tennessee Realtors *2023 State of Housing Report*, the Knoxville Metropolitan Statistical Area (MSA) home prices increased 15.9% from the previous year in Q4 2022. Rent prices continue to grow, with rents up 14.06% from the previous year, outpacing the national growth of 6.60%. This increase, along with the increased demand for both apartments and single-family rentals has led to almost half of all renter households in Knox County experiencing cost burdens and allocating at least 30% or more of their household income towards rent expenses.

A November 2023 study from Redfin⁴, showed that home buyers in the Knoxville MSA needed to have an annual household income of \$102,276 to buy the median-priced home in the area, with mortgage rates hitting 7% or more. The map below shows the share of households in Knox County Census Tracts with a household annual income less than \$100,000, utilizing data from the *2022 American Community Survey*.

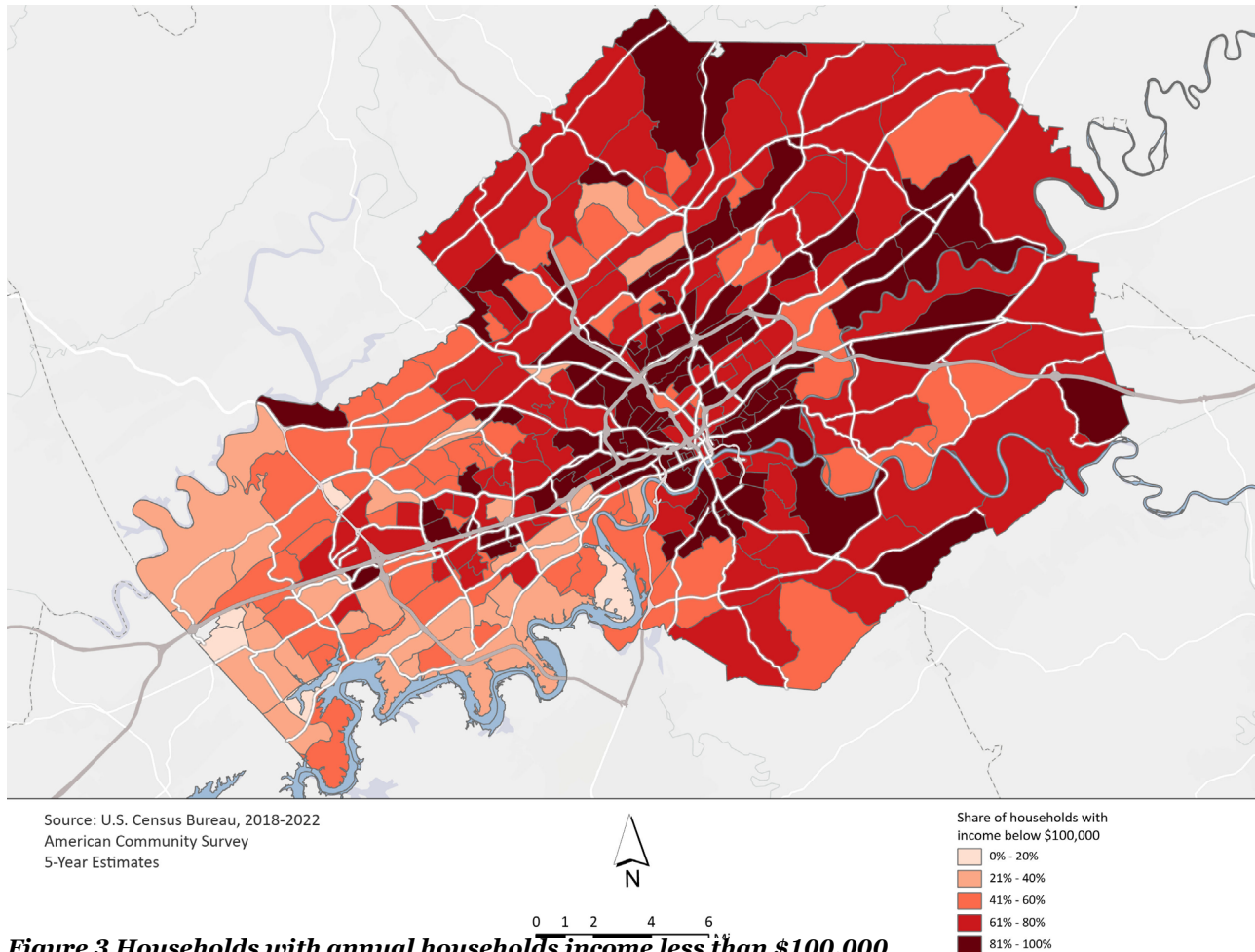


Figure 3 Households with annual household income less than \$100,000

Per the 2022 *American Community Survey*, the median household income in Knox County is \$68,580.

Actions it planned to remove or ameliorate the negative effects of public policies that serve as barriers to affordable housing such as land use controls, tax policies affecting land, zoning ordinances, building codes, fees and charges, growth limitations, and policies affecting the return on residential investment

Knox County is experiencing rapid growth, and the current land use rules are not conducive to sustaining this expansion. In response, the County is concluding the process of updating the *Growth Policy Plan* for the County in almost 20 years. Through a data-driven process, necessary updates to the plan guide growth, land use, transportation, economic development, and quality of life for residents and future residents.

Knox County champions affordable housing opportunities for both individuals and investors, making use of a variety of available resources. Additionally, the County oversees a collection of properties obtained through non-payment of property taxes, adhering to the regulations outlined in the Tennessee Code Annotated. This involves the periodic release of selected properties through annual tax sales. This distinctive approach enables interested individuals and investors to engage in bids for Knox County properties, which are offered at rates below market value. Consequently, this initiative promotes enhanced possibilities for individual and investor ownership of single-family housing within the county.

Discussion:

The current housing situation in Knox County underscores the urgent importance of prioritizing initiatives that uphold the preservation of naturally occurring affordable housing options and the expansion of affordable housing within the community. The County remains dedicated to actively monitoring housing market dynamics and flexibly adjusting project strategies as circumstances demand. In pursuit of these goals, the allocation of CDBG funds will play a crucial role in steering projects aimed at improving access to high-quality affordable rental housing, enhancing essential infrastructure to facilitate the growth of affordable housing stock, executing affordable single-family home restoration efforts, and actively advancing the overarching goal of increasing homeownership rates across the community.

AP-85 OTHER ACTIONS – 91.220(K)

Introduction:

The following are additional actions Knox County will take in the 2024 Program Year.

Actions planned to address obstacles to meeting underserved needs

All the activities funded under Knox County's HUD allocation will address the obstacles to meeting underserved needs. Additionally, the County will identify and respond to underserved needs as they arise from self-evaluation and citizen participation. Ongoing partnerships for Public Service programs will assist with not only responding to needs but being proactive as well.

The County's Comprehensive Opioid, Stimulant, and Substance Use Program (COSSUP) funds will be utilized to provide intensive case management services and substance disorder treatment to approximately 100 individuals annually on probation with substance use disorder who are at high risk of overdose. The program will assist individuals in obtaining treatment services, including peer recovery support and recovery housing.

Knox County and TN Homeland Security District 2 have been awarded a 2023 Regional Catastrophic Preparedness Grant (RCPG). The RCPG Program helps strengthen the core capabilities needed to make sure the district is secure and can bounce back from catastrophic disasters. The 2023 grant will support increasing long-term housing stability in disadvantaged communities by developing a regional response program focused on addressing the post-disaster needs of those communities. Additionally, the Knoxville-Knox County Office of Housing Stability is actively coordinating with local churches and social service partners to establish emergency weather centers throughout Knox County in cases of extreme weather. These centers are fully operational drop-in facilities with laundry, computers, and other needs to support those experiencing homelessness.

Actions planned to foster and maintain affordable housing

The County will utilize CDBG funding to improve the quality of existing housing stock through its Home Rehabilitation Program. This program preserves naturally occurring affordable housing through accessibility improvements and emergency home repairs. To better serve the residents of Knox County, KCGCD's Community Development (CD) Division is transitioning management of the Home Rehabilitation Program in-house. The CD Division will work directly with licensed contractors to perform specified repairs to the dwellings of eligible homeowners. The program provides emergency repair assistance aimed at preventing homelessness and addressing imminent threats to life, safety, or health. Residents have the opportunity to access grants designed to rectify deficiencies that pose significant risks, such as those endangering lives, health, or the security of their property.

Knox County will allocate its HOME funding towards at least one construction project, with the goal of enhancing the availability of affordable rental- housing units for low-to-moderate-income households. An agreement is slated to be executed in PY 2024 with a CHDO that will produce four floating HOME-assisted units with the remaining rental units being reserved for households at or below 80% AMI.

Actions planned to reduce lead-based paint hazards

Reduction of lead-based paint hazards is proactively addressed by the continuation of our Home Rehabilitation program. The County ensures provisional controls are implemented to reduce the lead-based paint hazards in the existing housing stock. Housing constructed before 1978, that are assisted with CDBG or HOME dollars, are evaluated for the presence of lead-based paint hazards, and controls or abatement are performed if identified during the assessment.

Actions planned to reduce the number of poverty-level families

To better empower individuals and families toward economic self-sufficiency, CDBG and HOME dollars may be used for the following strategies:

- Support sustainable economic development through affordable housing and other community development initiatives.
- Assess projects, in part, based on their potential to promote self-sufficiency when allocating funding.
- Foster a robust relationship with the Continuum of Care system to improve and advocate for the stabilization of homeless families, promoting a transition to stable households and housing situations.
- Explore collaborative opportunities with other agencies providing a variety of services and activities with a measurable, potentially significant impact on addressing the root causes of poverty in the community.
- Strengthen initiatives to inform the public and interested individuals about available supportive services that encourage self-sufficiency and facilitate independent living arrangements.

Additionally, the Knoxville-Knox County Office of Housing Stability's primary focus will be on ensuring that individuals and families in Knox County have access to safe, affordable, and stable housing.

Actions planned to develop institutional structure

Knox County is actively enhancing its capabilities and collaborating with non-profit agencies dedicated to serving LMI county residents. These agencies utilize grants to cover staffing and operational expenses related to public service and housing programs. The annual allocation of federal funding from HUD is essential, as without it, many subrecipients would need to curtail program outreach and services, thereby reducing the positive impact on the community's LMI individuals.

Actions planned to enhance coordination between public and private housing and social service agencies

KCGCD works to enhance the coordination between public and private housing and social services agencies by partnering with these local agencies to address the housing needs of Knox County. The County provides continuous technical assistance to ensure compliance with rules and regulations governing federal funding. Additionally, ongoing discussions with partners focus on reviewing activity accomplishments and devising creative solutions to address unique challenges encountered in the community. KCDGCD maintains and fosters relationships with service agencies by actively participating in community initiatives including the CoC and the All4Knox Housing Implementation Team.

Discussion:

Annually, the County opens a competitive application process inviting nonprofits and developers to submit funding proposals. Accessible through Neighborly, a web-based grant portal, both HOME and CDBG applications incorporate the County's grant/loan parameters, eligible activities, and compliance requirements. Technical assistance is readily available to support interested parties, addressing queries related to the grant portal and offering guidance on programmatic and regulatory obligations.

Eligible HOME beneficiaries encompass renters at or below 60% of the County's Area Median Income (AMI) and first-time homebuyers earning below 80% AMI. The County does not restrict funding beyond HUD parameters, allocating resources based on proposals aligning with the Knox County Consolidated Plan.

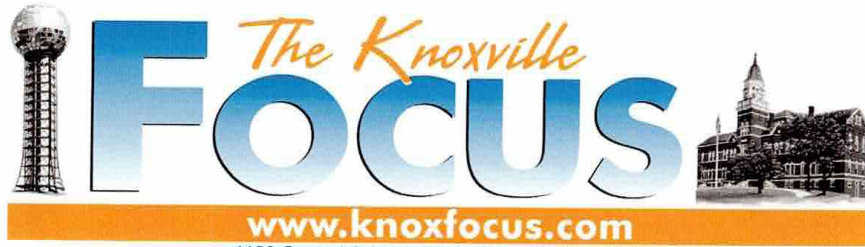
