Knox County Procurement Division Addendum I to Request for Proposals No. 2803 Toxicology Services

The following is for clarification:

- Q1. What specimens do you test in a typical case?
- A1. Blood typically. Vitreous or urine based on need. Gastric content and muscle are not typically tested.
- Q2. How frequently do you test multiple specimens per case?
- A2. Only blood is tested in about seventy-five percent (75%) of cases.
- Q3. How are you currently being charged if you submit a blood and urine/vitreous sample on the same case?
- A3. We are currently being charged separately because they are testing for different things
- Q4. Are you being charged separately for each specimen or is the urine/vitreous free/included when blood is tested?
- A4. Separately
- Q5. Is it the County's preference to be charged individually per specimen or to have a single flat price per case, regardless of the number of specimens tested?
- A5. It is the County's preference to have the lowest overall charge possible, whether it is per case or per test.
- Q6. Section 4.5.3 states very specific instrumentation requirements. Laboratories regularly upgrade their equipment. Is comparable or better equipment that is primarily UPLC/MS/MS sufficient for the County's requirements?
- A6. The county requires laboratories to maintain current testing and accreditation standards for the most accurate results possible.
- Q7. Forensic Laboratories often need to use a reference lab for complex drug cases and rare compounds. Is a reference laboratory considered a subcontractor in the context of this bid?
- A7. Yes
- Q8. Toxicology laboratories accredited by the American Board of Forensic Toxicology (ABFT) are only required to maintain records for a minimum of 5 years (and CLIA prescribes two years). Would the County accept this records maintenance schedule given it is an acceptable practice from ABFT?
- A8. Knox County would be agreeable to maintaining the records for 5 years or the term required by law, whichever is greater.
