Questions from the Pre-bid Meeting:

Question 1: Can the Contractors have the CADD files for the Proposed Cross Section?

Answer 1: The CADD Files for the Cross Sections will not be provided by Knox County.

Question 2: Can the Contractor have the Excel Files with the Proposed Quantities?

Answer 2: The Contractor will be provided the Excel files and Word documents with the quantities as a part of this Addendum. These are to be used for information and internal use only and not part of the bid response. The bid forms in the Project Manual are the only acceptable bid forms. Bid responses that contain these files instead of the bid form **will** be rejected.

Question 3: Are there any properties along the Route where borrow material can be obtained?

Answer 3: The Contractor will be provided as part of this Addendum two names of property owners who might be willing to give them access to their property for the excavation of borrow material. The Contractor will need to obtain any necessary Permits for this work. The Contractor may obtain this material at their own discretion. Knox County will not be held responsible for the cost of the Permits, any and all liability from obtaining and/or excavating the material, the quality of the material, or the seeding or sodding of any of these areas.

Question 4: Do the Utility Owners have a list of Approved Contractors that can be used on the project?

Answer 4: Yes, The Contractors will be provided a list from each of the Utility Owners as a part of this Addendum.
