- **ACCEPTANCE:** Vendors shall hold their price firm and subject to acceptance by Knox County for a period of ninety (90) business days from the date of the proposal closing, unless otherwise indicated in their proposal.
- **1.3** ALTERNATIVE PROPOSALS: Knox County will not accept alternate proposals (those not equal to specifications) unless authorized by the Request for Proposal.

- **1.8 CONFLICT OF INTEREST:** Vendors must have read and complied with the "Non-Conflict of Interest" statement provided in the vendor registration process prior to the closing of this solicitation.
- **1.9** COPIES: Knox County requires that proposals be submitted as one (1) marked original and one (1) exact copy. An electronic copy, in one complete file, is also requested on CD or flash-drive.
- **1.10 DECLARATIVE STATEMENTS:** Any statement or words (eg: must, shall, will etc.) are declarative statements and the proposer must comply with the condition. Failure to comply with any such condition may result in their proposal being non-responsive and disqualified.
- **1.11 ELECTRONIC TRANSMISSION OF PROPOSALS:** Knox County's Procurement Division will **not** accept electronically transmitted bids through the County's online Procurement system. Email and Facsimile are strictly prohibited.
- 1.12 HOW TO DO BUSINESS: Knox County utilizes a web-based Procurement software system, "KnoxBuys." The system provides our clients (vendors, county departments and the citizens of Knox County) with a more enhanced and end-user friendly means of accessing our services. The system allows for on-line vendor registration and maintenance, electronic receipt of purchase orders, on-line retrieval and submittal of quotes, bids and proposals for our vendor-clients and on-line requisitioning and receiving for our county departments. In order for the County to maximize its investment and minimize the cost associated with office operations we need your help. - **1.13 INCURRED COSTS:** Knox County will not be responsible for any costs incurred by the proposers in the preparation of their proposal.
- **1.14 MULTIPLE PROPOSALS:** Knox County will consider multiple proposals that meet specifications.
- **NEW MATERIAL:** Unless specified otherwise in the proposal package, the Contractor must provide new supplies. New, as used in this clause, means previously unused materials. Material includes but is not limited to, raw material, parts, items, components, and end products. Contractor submission of other than new materials may be cause for the rejection of the proposal.
- **1.16 NON-COLLUSION:** Vendors, by submitting a signed proposal certify that the accompanying proposal is not the result of, or affected by, any unlawful act of collusion with any other person or company engaged in the same line of business or commerce, or any other fraudulent act punishable under Tennessee or United States law.
- **1.17 PAYMENT METHOD:** Knox County utilizes two (2) methods of placing orders for products. The first is the use of Purchase Orders. These Purchase Orders will be issued from Knox County Procurement Division via the method selected by the vendor during registration. The Purchase Order will detail the quantity, specific item(s) and the contracted price for each item.

The second method is the use of the Knox County E-Commerce Card (VISA). Orders placed with the credit card will list the same information as the Purchase Order. Vendors will be given the card information and approval to process the transactions by the requesting department. Any such protest or question regarding the specifications or proposal procedures must be received in the Procurement Division by **January 18, 2023, at 4:30 p.m. local time.** These requirements also apply to specifications that are ambiguous.
- 1.24 <u>SIGNING OF PROPOSALS:</u> In order to be considered, all proposals must be signed. Please sign the original in blue ink. By signing the proposal document, the vendor acknowledges and accepts the terms and conditions stated in the bid document.
- **1.25 TAXES:** Knox County purchases are not subject to taxation. Tax exemption certificates will be provided upon request.
- **1.26 TERM AGREEMENT:** If this proposal results in a term contract with the vendor, Knox County must receive all general price decreases that other customers receive.
- 1.27 <u>TITLE VI OF THE 1964 CIVIL RIGHTS ACT:</u> "Nondiscrimination in Federally Assisted Programs"—"No person in the United States shall, on the ground of race, color, or national origin, be excluded from participation in, be denied the benefits of, or be subjected to discrimination under any program or activity receiving Federal financial assistance." 42 U.S.C. Section 2000 et seq.lt is the policy of Knox County Government that all its services and activities be administered in conformance with the requirements of Title VI.
- **1.28** <u>USE OF PROPOSAL FORMS:</u> Proposers are to complete and return the proposal forms contained in the proposal package. Failure to complete the proposal forms may result in proposal rejection.
- 1.29 <u>VENDOR DEFAULT:</u> Knox County reserves the right, in case of vendor default, to procure the articles or services from other sources and hold the defaulting vendor responsible for any excess costs occasioned thereby. Should vendor default be due to a failure to perform or because of a request for a price increase, Knox County reserves the right to remove the vendor from the County's Proposers list for twenty-four (24) months.

- 1.30 <u>VENDOR REGISTRATION:</u> Prior to the closing of this proposal, *ALL PROPOSERS* must be registered with the Procurement Division. A vendor application may be submitted online at www.knoxcounty.org/procurement. Select the On-Line Vendor Registration link and complete the forms. Vendors must be registered with the Procurement Division **prior** to submitting their proposal. Knox County shall not be responsible for technical difficulties experienced by vendors trying to register less than twenty-four (24) hours prior to the proposal closing time.
- **1.31 WAIVING OF INFORMALITIES:** Knox County reserves the right to waive minor informalities or technicalities when it is in the best interest of Knox County.

SECTION II OBLIGATIONS, RIGHTS AND REMEDIES

These terms and conditions shall be part of the Contract. Knox County reserves the right to negotiate other terms and conditions it deems appropriate and necessary under the circumstances to protect the public's trust.

- **2.1 ALTERATIONS OR AMENDMENTS:** No alterations, amendments, changes, modifications, or additions to this Contract shall be binding on Knox County without the prior written approval of the County.
- **ASSIGNMENT:** Contractor shall not assign or sub-contract this agreement, its obligations, or rights hereunder to any party, company, partnership, incorporation, or person without the prior written specific consent of Knox County.
- **APPROPRIATION:** In the event no funds are appropriated by Knox County for the goods or services in any fiscal year or insufficient funds exist to purchase the goods or services, then the Contract shall expire upon the expenditure of previously appropriated funds or the end of the current fiscal year, whichever occurs first, with no further obligations owed to or by either party.
- **BOOKS AND RECORDS:** Contractor shall maintain all books, documents, accounting records and other evidence pertaining to the goods and services provided under this Contract and make such materials available at its offices at all reasonable times during the contract period and for three (3) years from the date of the final payment under this agreement for inspection by County or by any other governmental entity or agency participating in the funding of this agreement, or any authorized agents thereof; copies of said records to be furnished if requested. Such records shall not include those books, documents and accounting records that represent the Contractor's costs of manufacturing, acquiring, or delivering the products and services governed by this agreement.
- **2.5 CHILD LABOR:** Contractor agrees that no products or services will be provided or performed under this Contract that have been manufactured or assembled by child labor.
- **2.6 COMPLIANCE WITH ALL LAWS:** Contractor is assumed to be familiar with and agrees to observe and comply with all federal, state, and local laws, statutes, ordinances, and regulations in any manner affecting the provision of goods and/or services, and all instructions and prohibitive orders issued regarding this work and shall obtain all necessary permits.
- **2.7 DEFAULT:** If Contractor fails to perform or comply with any provision of this Contract or the terms or conditions of any documents referenced and made a part hereof, Knox County may terminate this Contract, in whole or in part, and may consider such failure or noncompliance a breach of contract.
 - Knox County expressly retains all its rights and remedies provided by law in case of such breach, and no action by Knox County shall constitute a waiver of any such rights or remedies. In the event of termination for default, Knox County reserves the right to purchase its requirements elsewhere, with or without competitive proposing.
- 2.8 GOVERNING LAW; VENUE: This agreement shall be exclusively construed, governed, and controlled by the Laws of the State of Tennessee without regard to principles of law, including conflicts of law, of any other jurisdiction, territory, country, and/or province. Any dispute arising out of or relating to this agreement shall exclusively be brought in the Chancery Court or the Circuit Court of Knox County, Tennessee. Each party consents to personal jurisdiction thereto and waives any defenses base on personal jurisdiction, venue, and inconvenient forum.
- **2.9 INCORPORATION:** All specifications, drawings, technical information, Request for Proposal, Proposal, Award, and similar items referred to or attached or which are the basis for this Contract are deemed incorporated by reference as if set out fully herein.

- **INDEMNIFICATION/HOLD HARMLESS:** Contractor shall indemnify, defend, save, and hold harmless Knox County, its officers, agents and employees from all suits, claims, actions or damages of any nature brought because of, arising out of, or due to breach of the agreement by Contractor, its subcontractors, suppliers, agents, or employees or due to any negligent act or occurrence or any omission or commission of Contractor, its subcontractors, suppliers, agents or employees.
- **2.11 INDEPENDENT CONTRACTOR:** Contractor shall acknowledge that it and its employees serve as independent contractors and that Knox County shall not be responsible for any payment, insurance, or incurred liability.
- 2.12 INSPECTION AND ACCEPTANCE: Warranty periods shall not commence until Knox County inspects and formally accepts the goods and/or services. The terms, conditions and timing of acceptance shall be determined by Knox County. Knox County reserves the right to reject any or all items or services not in conformance with applicable specifications, and Contractor assumes the costs associated with such nonconformance. Acceptance of goods or services does not constitute a waiver of latent or hidden defects or defects not readily detectable by a reasonable person under the circumstances.
- **2.13 IRAN DIVESTMENT ACT:** By submission of this proposal, each proposer and each person signing on behalf of any proposer certifies, and in the case of a joint proposal each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each proposer is not on the list created pursuant to Tennessee Code Annotated § 12-12-106.
- **2.14 LIMITATIONS OF LIABILITY:** In no event shall Knox County be liable for any indirect, incidental, consequential, special, or exemplary damages or lost profits, even if Knox County has been advised of the possibility of such damages.
- 2.15 NO BOYCOTT OF ISRAEL: Pursuant to Tennessee Code Annotated Title 12, Chapter 4, Part 1, by submission of a response to this solicitation, each proposer and each person signing on behalf of any proposer certifies, and in the case of a joint response each party thereto certifies as to its own organization, under penalty of perjury, that to the best of its knowledge and belief that each proposer is not currently engaged in, and will not for the duration of the contract engage in, a boycott of Israel.
- 2.16 NON-DISCRIMINATION AND NON-CONFLICT STATEMENT: Contractor agrees that no person on the grounds of handicap, age, race, color, religion, sex, national origin, or any individual trait or characteristic found to be an illegal consideration shall be excluded from participation in, or be denied benefits of, or be otherwise subjected to discrimination in the performance of this agreement, or in the employment practices of vendor. Contractor shall upon request show proof of such non-discrimination and shall post in conspicuous places available to all employees and applicants notices of non-discrimination. Contractor covenants that it complies with the Fair Wage and Hour Laws, the National Labor Relations Act, and other federal and state employment laws as applicable. Contractor covenants that it does not engage in any illegal employment practices.

Contractor covenants that it has no public or private interest, and shall not acquire directly or indirectly any interest, which would conflict in any manner with the provision of its goods or performance of its services. Contractor warrants that no part of the total contract amount provided herein shall be paid directly or indirectly to any officer or employee of Knox County as wages, compensation, or gifts in exchange for acting as officer, agent, employee, subcontractor, or consultant to Contractor in connection with any goods provided or work contemplated or performed relative to the agreement.

- 2.17 ORDER OF PRECEDENCE: In the event of inconsistent or conflicting provision of this Contract and referenced documents, the following descending order of precedence shall prevail: (1) Written Contract, (2) Request for Proposal, (3) Vendor's response to Request for Proposal, (4) Award, (5) Special Terms and Conditions, (6) General Terms and Conditions, (7) Specifications, (8) Drawings.
- **2.18 REMEDIES:** Knox County shall have all rights and remedies afforded under the U.C.C. and Tennessee law in contract and in tort, including but not limited to rejection of goods, rescission, right of offset, refund, incidental, consequential, and compensatory damages, and reasonable attorney's fees.
- **2.19** RIGHT TO INSPECT: Knox County reserves the right to make periodic inspections of the manner and means the service is performed or the goods are supplied.

- **2.20 SEVERABILITY:** If any provision of this Contract is declared illegal, void or unenforceable, the remaining provisions shall not be affected but shall remain in force and in effect.
- **TAX COMPLIANCE:** Pursuant to Resolution R-07-1-903 passed by the Commission of Knox County, Tennessee, Contractor hereby acknowledges by submission of its proposal or proposal and signature that it is current in its respective Federal, State, County and City taxes of whatever kind or nature and is not delinquent in any way. Delinquent status must be disclosed or risk debarment by the Knox County Procurement Division.
- **TERMINATION:** County may terminate this agreement with or without cause at any time upon thirty (30) business days with written notice. In the event of termination by either party, fees due for services satisfactorily performed or goods accepted prior to the termination date shall be paid.
- **WARRANTY:** Contractor warrants to Knox County that all items delivered and all services rendered shall conform to the specifications, drawings, proposal and/or other descriptions furnished and/or incorporated by reference, and will be fit for the particular purpose purchased, of merchantable quality, good workmanship, and free from defects. Contractor extends to Knox County all warranties allowed under the U.C.C. Contractor shall provide copies of warranties to the County. Return of merchandise not meeting warranties shall be at contractor's expense.

SECTION III SPECIAL TERMS AND CONDITIONS

- 3.1 <u>INTENT:</u> The intent of these specifications is to set forth and convey to prospective proposers the general type, character and quality of Police Service Dogs desired by Knox County and the Knox County Sheriff's Office. This solicitation may result in a multi-year term agreement, renewed on an annual basis at the sole discretion of the Knox County Sheriff's Office. Award will be based on Best Value. Best Value means more than low cost. It includes the initial cost, service, quality, and other factors detailed herein.
- **AWARD LENGTH:** The length of this contract will be one (1) year with the option to renew upon mutual consent of both parties. The term agreement may be renewed for four (4) one-year periods, one (1) year at a time, for a total of five (5) years. Knox County reserves the right to purchase these services from other sources if the need arises. Knox County reserves the right to revoke the award if a pattern of unavailability arises with the vendor.
- 3.3 <u>ADDITIONS / DELETIONS:</u> Knox County reserves the right to add items/services to this term agreement or delete items/services that have become obsolete in demand. Additional products or services will be agreed upon by both parties in writing and will be made part of the official proposal file.
- 3.4 BACKGROUND CHECKS: A Knox County Sheriff's Office background check may be required for any or all employees of the Contractors staff providing services to Knox County. Any cost will be borne by Knox County. Certain felony convictions will prevent individual persons from being on Knox County property. These generally include those offenses that would tend to endanger the health or welfare of persons or staff.
- 3.5 CHANGES AFTER AWARD: It is possible that after award, Knox County might change its needs or requirements. Knox County reserves the right to make such changes after consultation with the vendor. Should additional costs arise, Knox County reserves the right to consider accepting these charges provided the vendor can document the increased costs. Knox County reserves the right to make such changes after consultation with the vendor. Knox County also reserves the right to accept proposed service changes from the vendor if they will lower the cost to Knox County and/or provide improved services.
- 3.6 <u>CONTACT PERSON:</u> Each proposer must list the name and address of the designated contact person to maintain service with this account during the term of the contract. Proposer must provide an organizational chart of their company hierarchy to include names, titles, and telephone numbers. Any changes with the contact personnel must be communicated with the County as expeditiously as possible.
- 3.7 <u>CONTRACT EXECUTION:</u> The award of this proposal may result in a contract between Knox County and the successful vendor. The Knox County Procurement Division will draft the contract and the contract must be approved by the Knox County Law Department and County Commission. Knox County will not accept any vendors' contracts or Terms of Agreements, Service Agreements, etc.
- 3.8 <u>DESTINATION AND DELIVERY:</u> Proposers must include all destination and delivery charges in their price. There will be no extra hidden charges.

3.9 <u>DEVIATIONS FROM SPECIFICATIONS:</u> Knox County wishes to secure proposals that best suits our needs. Proposers may submit more than one proposal; accordingly, each proposal must state either that it conforms exactly to, or deviates from, the specification. Knox County shall be informed of any deviations from these specifications. Deviations shall be clearly noted. Adequate information must be provided to allow Knox County to evaluate these exceptions.

3.10 EVALUATION CRITERIA:

Resources 55 Points
Experience and Qualifications 30 Points
Cost 15 Points

Knox County may select an Evaluation Committee for this solicitation to thoroughly review and score all submitted responsive and responsible proposals. Each evaluator will have the ability to award up to 100 points, based on the Evaluation Criteria, per submission.

- 3.11 <u>EVALUATION REVIEW:</u> Knox County reserves the right to use all pertinent information that might affect the County's judgment as to the appropriateness of an award to the best evaluated proposer. This information may be appended to the proposal evaluation process results. Information on a service provider from reliable sources, and not within the service provider's proposal, may also be noted and made part of the evaluation file. Knox County shall have sole responsibility for determining a reliable source. Knox County reserves the right to conduct written and/or oral discussions/interviews after the proposal closing. The purpose of such discussions/interviews is to provide clarification and/or additional information to make an award that is in the best interest of Knox County.
- **3.12 INTERPRETATION:** No oral interpretation will be made to any bidder regarding the meaning of specifications. All questions are to be submitted in writing or electronically (email) and will be answered in the form of an amendment to the solicitation by the Knox County Procurement Division.
- 3.13 <u>INVOICING:</u> All invoices shall be mailed in duplicate to the Knox County Sheriff's Office, 400 Main Street, Suite L-149, Knoxville, TN 37902. All invoices must show the Purchase Order number or Contract number. Without this information, the invoice may be rejected for payment. Invoices can also be emailed to invoices@knoxsheriff.org.
- 3.14 NEWS RELEASES BY VENDORS: As a matter of policy, Knox County does not endorse the services of a Contractor. A Contractor will not make news releases concerning any resultant Contract from this solicitation without the prior written approval of Knox County.
- 3.15 NO CONTACT POLICY: After the date the vendor receives this proposal, any contact initiated by any proposer with any Knox County representative, other than the Procurement Division representative listed herein, concerning this solicitation is prohibited. Any such unauthorized contact may cause the disqualification of the proposer from this procurement transaction.
- 3.16 OPEN RECORDS ACT: Knox County is subject to the Tennessee Open Records Act 10-7-503 et seq. Proposers are cautioned that all documents submitted on behalf of this Request for Proposal shall be open to the public for viewing and inspection and Knox County will comply with all legitimate requests. Submission of your proposal will be an acknowledgement to this provision.
- 3.17 PRICING: The bidder warrants that the unit price stated shall remain firm for a period of twelve (12) months from the first day of the contract period. After the first contract year (and each subsequent year thereafter), the contractor(s) written request for a price increase must be given to Knox County to consider. Such a request shall include a minimum:
 - The cause for the adjustment
 - The cause of the change requested with documentation to support the requested adjustment.

Price increases will only be considered during the renewal period(s) which is approximately ninety (90) days prior to expiration. If the price increase is rejected, the contractor may:

- Continue with the existing prices
- Request a lower price increase
- Not accept the renewal offer

If a price increase is approved by Knox County and the Knox County Sheriff's Office, the approval notification will be done in writing and the contractor will be notified of the new price schedule and effective date of increase. This documentation will become part of the bid file. No approvals will be authorized verbally.

- **3.18 QUANTITIES:** Knox County does not guarantee any quantities of items to be purchased. Orders will be issued on an as needed basis.
- **REFERENCES:** Vendor must provide three (3) current references relating to work of a similar scope completed within the last three (3) years. If provided with inaccurate information, Knox County will not attempt to obtain correct contact and references will be scored accordingly. Please use attachment "A" to submit with proposal.
- **REMOVAL OF VENDORS EMPLOYEES:** The successful vendor agrees to utilize only experienced responsible and capable people in the performance of the work. KCSO may require that the successful vendor remove from the job covered by this Contract, employees who endanger persons or property or whose continued employment under this contract is inconsistent with the interest of KCSO.

- **3.22 SAFETY TRAINING:** The Contractor is responsible for training their employees in Safety and Health Regulations for the job, assuring compliance with Tennessee Occupational Safety and Health regulations and any other Regulatory Agency.

SECTION IV SCOPE OF SERVICES

This Request for Proposals (RFP) outlines the scope of services and requirements that must be addressed by any Contractor interested in supplying Police Service Dogs for Knox County. The contractor is to provide all personnel and their own materials, equipment, insurance, and supervision necessary to provide the services detailed herein. Contractor is to provide a not-to-exceed cost for all animals purchased under this agreement.

- **KENNEL FACILITY REQUIREMENTS:** The kennel must conform to all Federal, State and Local requirements as well as any applicable zoning laws. The owner must own the training land and facilities or have a long-term lease or an option on said land and facilities for at least two (2) years. The facility must have an area that allows for the training or testing of prospective dogs. The facility must include adequate course and search areas that are large enough to test speed, agility, and olfactory prowess.
- **POLICE DOG MINIMUM REQUIREMENTS:** The KCSO Trainer will be solely responsible for making the final determination of which dog(s) are to be purchased based upon the physical condition, characteristics, and traits of each dog. The successful proposer must furnish the Knox County Sheriff's Office an original veterinary health certificate from the country of origin, detailing the dog's name or tattoo, age, and health history, which must include all record of all veterinarian visits.

The following is an outline of minimum requirements:

Acceptable Breeds: Belgian Malinois, Dutch Shepherd, German Shepard Import Green or Titled and Other Breeds Import Green or Titled (all "Other Breed" submittals must be pre-approved by the Knox County Sheriff's Office).

Canine Age: At the discretion of the KCSO K9 staff.

Physical condition of dog as evidenced by:

- Absence of hip dysplasia and front elbow/limb inferiority as determined and verified by radiographs taken by the
 proposer's veterinarian and read by the County's veterinarian.
- Absence of heart worms as confirmed by negative test results, administered by the County's veterinarian.
- Successful completion of a routine physical examination by the County's veterinarian. The examination is to include: blood work, parasite check, oral (dental-gums), eyes, ears, weight, and overall physical evaluation to establish that the animal is suited for and will endure the stress of training and street work. Knox County will bear this expense.

Dog Evaluation: Proposer must agree to the testing of the prospective dog(s) by the Knox County Sheriff's Office Canine Unit as part of the screening process for selection of qualified police work dogs. Proposer must have at least one (1) police service dog available for testing. Dogs must be available for testing within twenty-one (21) working days from date of notification.

The dog must pass the evaluation test for temperament, courage, hardness, sharpness, and instinctive drive test administered by the canine unit training personnel, to the satisfaction of the canine unit sergeant or designated evaluator. Dogs will be evaluated for various characteristics including but not limited to, appearance, strength, initiative, intelligence, alertness, curiosity, agility, courage, drive, persistence, possessiveness, play and sociability. Dogs will be placed in various situations to display ability to various situations to react to noise/people and interaction with the handler.

Proposer must be willing and able to replace an animal within twenty-one (21) business days that has been deemed unacceptable through testing with an equally acceptable dog, as determined by the Knox County Sheriff's Office Canine Unit supervisor, at no additional cost. Should the dog fail training at any point within the first ninety (90) days or is not certified by the Knox County Sheriff's Office K-9 Academy within one hundred and eighty (180) calendar days. If the rejected animal cannot be replaced within twenty-one (21) business days, the successful proposer must refund all monies received from the County for the purchase of the dog and all expenses associated with transportation of said animal.

Expenses for the animal's care will be the responsibility of the Knox County Sheriff's Office during the time the animal is in custody of the Knox County Sheriff's Office Canine Unit. The Knox County Sheriff's Office will guarantee appropriate veterinary care, feeding and handling of the dog while in the custody of the Knox County Sheriff's Office.

- **4.3 TRAINER QUALIFICATIONS:** At a minimum, trainers must also provide the following:
 - (1.) Proof of a minimum of three (3) years training experience,
 - (2.) Proof of Police Canine Training Certification,
 - (3.) Proof of providing training for Police Canines for a minimum of three (3) law enforcement agencies.
