THE FOLLOWING IS FOR CLARIFICATION:

- Question 1:** For the disposable glove portion of this bid, lines 49-55, are you able to provide an estimated annual usage? I know there aren't set quantities but an estimate will help us determine delivered pricing for each item, as freight costs vary between quantities. Would you happen to also have the usage on the previous bid for this item? Any info would help.
- Answer 1:** The Knox County Health Department Dentist saw 4,000 patients last year. The Dentist uses 2 pairs of gloves per patient and the Hygienist uses one pair per patient.
- Question 2:** Could you please supply the vendor item # for each of the products on the bid list?
- Answer 2:** We do not have item numbers for any of the items on the pricing sheet. Please refer to 1.7 of the bid document.
- Question 3:** I can't seem to find any specifications for the nitrile gloves. Are you asking for 3.5 mil, 4 mil, 5 mil? Also, it looks like the gloves are the basic exam gloves. Just confirming that there is no need for the deluxe gloves that provide chemotherapy and fentanyl protection. Please advise. Look forward to your reply.
- Answer 3:** The Knox County Health Department Dentist says that he is not sure of the mil sizes but that they use sizes Extra Small to Extra Large. There is no need for gloves with chemotherapy and fentanyl protection.
- Question 4:** Would you be able to share what type of facility(ies) this request is for?
- Answer 4:** Knox County Health Department
- Question 5:** What item numbers are for the Cranberry gloves ? Asking, because we are the exclusive distributor for Cranberry Evolve 300ct (Chemotherapy and Fentanyl protection) 300 per bx. Most Cranberry gloves are 200 to 300 per box. I'm not recognizing what you're specifying in a box of 100.
- Answer 5:** There are no item numbers for the items on the pricing sheet. Please refer to 1.7 of the bid document. Chemotherapy and Fentanyl protection gloves are not needed.
