SITE VISIT: A second site visit will be held on Tuesday, October 17, 2023 at 10:00 a.m. at French

Memorial Park, 7752 Martin Mill Pike, Knoxville, TN. 37920. The purpose of this site visit is to meet with the utility companies to answer questions regarding the location of the utilities

as well as the splash pad.

QUESTIONS: Prospective proposers will be allowed to ask follow up questions until 4:30 p.m. local time,

Thursday, October 19, 2023.

The following is for clarification.

Question 1. Can the county provide a utility plan showing sewer/water/storm/electrical locations?

Answer 1. See above. A second site visit will be held.

Question 2. Is the 4000 gallon tank required regardless of feature flow rate? Can we reduce the size as long as we stay

within health department standards?

Answer 2. Yes, the 4000-gallon tank is required.

Question 3. Can you provide the specific location at the park where the splash pad is intended to be installed?

Answer 3 Yes, please see attached map.

Question 4. Is there a recommended theme/style of the splash pad features the county is looking to achieve?

Answer 4. We would like a Veterans theme but are open to other options.

Question 5. Are you requiring sealed plans for the project?

Answer 5. Yes.

Question 6. Are there any structural/style requirements for the pump room?

Question 7. In order to properly quote this, given the limited time, we will need additional time for the bid to be

completed. Can we have an extension of approximately 3-4 weeks to complete this bid process?

Answer 7. Yes.

Question 8. Pump House – Direction on what you want this to look like? Similar to what is onsite or otherwise?

Answer 8. See answer 6.

Question 9. Will the sewer line be brought up to the splash pad within 10'

Answer 9. No.

Question 10. Will the water line will be brought up to splash pad within 10'

Answer 10. No.

Question 11. Will the power be brought up to splash pad within 10'

Answer 11. No.

Question 12. Location of where the splash pad will be located? Aerial View?

Answer 12. See answer 3.

Question 13. Is there a desired theme?

Answer 13. See answer 4.

Question 14. Should we include LED lights with spray jets? (this is mentioned in 4.4.6 about the controller)

Answer 14. No, we do not need LEDs in the spray jets.

Question 15. Please give more information about the separate vault for chlorine and acid tanks. Above or below ground?

Answer 15. Above ground located in the pump house with separate spill drains.

Question 16. Any landscaping or site reclamation?

Question 17. Is concrete with a broom finish acceptable? "Aquatic surfacing"? Or do you want EPDM or rubberized

paint?

Answer 17. Concrete with a broom finish is preferred.

Answer 18. It is always a possibility.

Question 19. Is any additional lighting needed?

Answer 19. No.

Do you want a fence around it? Question 20.

Answer 20. Yes. The County requests the fence be equal to the Freedom New Haven 4-ft H x 6-ft W Black Aluminum

> Spaced Picket Flat-top Decorative Fence Panel. The County is not requesting this specific fence. The reference to the brand name is to provide proposers with the general type and quality of the fence

desired.
