Questions and Answers.

- **Q.1.** I noticed on the solicitation it did not list anything about feminine hygiene products or dispensers for those products. Is that something that we could potentially still bid on?
- A.1. Knox County is not adding, nor accepting bids for, feminine hygiene products or dispensers at this time.
- Q.2. Is it possible to receive the previous bid tab and current prices being paid?
- A.2. The bid tab for any previously awarded bids may be obtained on the Knox County website at <u>https://www.knoxcounty.org/apps/solicitations/recent_awards.php</u>. The current prices vary depending on which of several vendors the order is placed with.
- **Q.3.** Toothpaste what brand are you currently using and current price being paid and to what vendor.
- A.3. We use a variety of brands therefore the prices vary. We use the vendor who provides the product we need at the best price.
- Q.4. Bic Razor would you be open to using a Bob Barker Brand razor?
- **A.4.** We use the single blade Bic style/type razor with the safety cap. Typically we use the 1000 Razors per case with 10 boxes (of 100 razors per box) per case, with a safety cap. We would not require other options unless the dollar amount in savings is notable.
- Q.5. Is it possible to bid multiple options on one bid?
- **A.5.** Yes. Section 1.17 of the Bid Document states Knox County will consider multiple bids that meet specifications. If bidding electronically, you can upload additional pages as needed.
- Q.6. Toilet paper: what brand are you currently using? How much do you typically order at one time?
- **A.6.** We use a variety of brands and typically order 50-150 cases at a time but will never guarantee any specific amount will be ordered from any one company.
- Q.7. What price are you paying for both toilet papers if it is not included in the last bid tab?
- A.7. We use a variety of brands so the amount paid can vary.
- Q.8. Would you consider a minimum order of 70 cases for the toilet paper?
- **A.8.** As stated in question #5, we typically order 50-150 cases at a time, however we will not guarantee any specific amount will be ordered from any one company.
- Q.9. How much do you typically order of each item at one time?
- **A.9.** As stated in questions #5 and #7, we typically order 50-150 cases at a time, however we will not guarantee any specific amount will be ordered from any one company.
